PARTICIPATION REQUEST GENERAL RULES

1. The present participation request to the fair is irrevocable on the part of the exhibiting company, the request is considered completed with the subscription. The exhibiting company declares to have read the information related to the provisioned services. The exhibiting companies must submit the participation request and possess the requisites and authorizations required by law for their commercial activities. The acceptance of the participation request and the allocation of exhibition spaces depend on the availability. Not compliance with the current provisions of law will result in the non acceptance of the participation request.
2. Acceptance of General Rules: the exhibiting company can withdraw up to 40 days before the fair paying the deposit as a fine. In case of late withdrawal the total fee will be charged.
3. The exhibiting company declares to have read and accepted the general rules and regulations. The participation fee includes only the services listed in the participation request; any other services and/or extra stand furniture must be paid for separately. The exhibiting company has the responsibility of cleaning the stand.
4. International Group S.r.l. takes care of the commercial and logistic organization of the Fair, of the fair pavilion and of its promotion; it is not responsible for the commercial feedback and the influx of visitors to the event. In compliance with the contract terms, International Group S.r.l. undertakes to supply all the services commissioned in the participation request. The exhibiting company must respect the fair opening hours and the schedule for the assembly and dismantling of the stands. In the case the exhibiting company arbitrarily decides to dismantle the stand before the end of the event it will be held responsible for damages caused at an organizational, commercial and image level.
5. The exhibiting company recognizes that all the services of International Group S.r.l. included databases, websites, counseling, texts, etc. are exclusive property of International Group S.r.l. and may not be used without prior written authorization by International Group S.r.l.
6. The exhibiting company must respect the payment deadline. The deposit must be paid at the same time as the transmission of the participation request. The balance must be settled on the due date. In the event of non-payment of the deposit and the balance, the exhibiting company recognizes the right of the International Group S.r.l. to exclude him from the event and to request the payment of the deposit as a penalty.
7. International Group S.r.l. is absolved of any liability for damages to third parties resulting from the activities of the exhibiting company during the event. International Group S.r.l. is absolved of any liability towards third parties in case of theft and damage caused or suffered by the exhibiting company. The exhibiting company is civilly and criminally responsible for its activity and that of its collaborators. The exhibiting company must take out a theft and third party liability insurance policy.
